NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to approve the scheme of “The Puducherry Free Supply of Clothing Items to the Differently Abled person Rules, 2020”. The said rules as approved by the Lieutenant-Governor, is hereby notified.

THE PUDUCHERRY FREE SUPPLY OF CLOTHING ITEMS TO THE DIFFERENTLY ABLED PERSONS RULES, 2020

1. Short title, extent and commencement.– (i) These rules may be called the “The Puducherry Free Supply of Clothing Items to the Differently Abled person Rules, 2020”
 - (ii) They shall extend to the whole of the Union territory of Puducherry.
 - (iii) They shall come into force on and from the date of their publication in the official gazette.
2. Objective of the scheme.– The objective of the scheme is to disburse cash dole to the differently abled persons in the Union territory of Puducherry, who are receiving monthly Financial Assistance under the Scheme “Payment of Financial Assistance to the differently abled persons” implemented by the Department of Social Welfare, Puducherry.
3. Definitions.- In these rules, unless the context otherwise requires,-
 - (i). “Government” means the Administrator of the Union territory of Puducherry appointed by the President under article 239 of the Constitution;
 - (ii). “Director” means the Director for the Department of Social Welfare, Puducherry;
 - (iii). “Differently Abled Person” in this context refers to those persons who are receiving monthly Financial Assistance under the scheme “Payment of Financial Assistance to the differently abled persons” implemented by the Directorate of Social Welfare and have completed 18 years of age.
4. Eligibility.- The assistance under this scheme shall be granted to those persons who are receiving Monthly Financial Assistance under the Scheme “Payment of Financial Assistance to the differently abled persons” implemented by the Department of Social Welfare and have completed 18 years of age and are not in receipt of such benefits under any other scheme.

5. Nature of Assistance.-

(a) Cash dole of Rs.500/- will be credited into the bank account of Beneficiary once in a year on account of Diwali, Pongal or other festival occasions.

(or)

(b) The value of cash dole under the scheme in respect of male/female beneficiaries will be decided by a three member committee headed by the Hon'ble Chief Minister including Hon'ble Minister for Welfare and the Secretary to Govt. (Social Welfare) as other members from time to time.

6. Mode of Selection.- The list of Male/Female differently abled person who are receiving Monthly Financial Assistance and who have attained 18 years of age as on the eve of the festival and are not in receipt of such benefits under any other scheme will be determined from the Database of the Scheme "Payment of Financial Assistance to the differently abled persons" maintained by the National Informatics Centre of the respective regions for disbursement of cash dole under the scheme.

7. Mode of distribution.- Cash dole will be electronically credited into the bank account of Beneficiary.

8. Removal of Doubts.- If any doubt arises as to the interpretation of these rules, the decision of the Government thereon, shall be final.
